



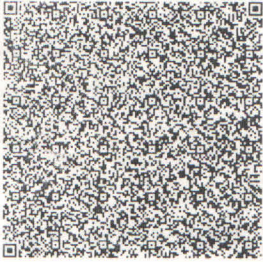

PARTNERSHIP DEED

This deed of partnership executed on 28th day of January 2015-among:-

Mr. Ravi Kant Jha Son of Sh. Ram Narayan Jha Resident of A-223, Raja Puri, Bharat Vihar, Uttam Nagar, Delhi - 110059. Hereinafter after known as the first party.

AND

Mr. Ajit Kumar Jha Son of Sh. Ram Narayan Jha Resident of A-223, Raja Puri, Bharat Vihar, Uttam Nagar, Delhi - 110059. Hereinafter after known as the Second party.

AND

Mr. Pawan Kumar Jha Son of Sh. Ram Narayan Jha Resident of A-223, Raja Puri, Bharat Vihar, Uttam Nagar, Delhi - 110059. Hereinafter after known as the Third party.

WHEREAS the parties here to have agreed to run the business of labour contracting works, and / or provide manpower for job work, etc. under the name & style of "**Jha Brothers Services**"

AND

WHEREAS the parties here to have agreed upon the terms & condition of the said partnership to writing.

THIS DEED WINESETH AS FOLLOWS:-

1. That the name & style of the partnership firm is "**Jha Brothers Services**"
2. That the business of the partnership firm will be to take up labour contracting works, and / or provide manpower for job work, etc.
3. That the partnership firm has commenced from 28th day of January 2015 and is a partnership at will.

4. That the particular place of business of the partnership firm is at A-223, Raja Puri, Bharat Vihar, Uttam Nagar, Delhi - 110059 and the firm may carry on business at other places and in such other name or names or styles as the parties may from time to time mutually decide.
5. That the parties hereto will subscribe such capital as may be agreed upon from time to time and shall arrange for finances or loan or by such resources as may from time to time be considered expedient in the interest of the business.
6. That the parties hereto shall not be entitled to any interest on their capital investment.
7. That each party shall have the following share in the profits (or loses, if any)

Mr. Ajit Kumar Jha	33%
Mr. Pawan Kumar Jha	33%

8. That the bank account of the firm will be opened in a Bank which shall be operated upon by any one of the partner either severally or jointly and each partner shall be at liberty to draw cheques in the name of the firm.
9. That none of the parties will be entitled to any salary. However, each partner can withdraw any sum that is mutually agreed by all the parties. While computing each partners share these withdrawals will be added to the profit (or deducted from the loss) to arrive at the Gross profit/loss of the firm. This gross profit will be the eligible amount for computing each partners share. From this eligible partner's share the amount already withdrawn will be deducted to arrive at the net profit share of each partner.
10. That book of accounts shall be maintained for the business or businesses of the partnership firm and that each of the parties hereto shall have free access to the books of account at all reasonable times and the accounting year will be 1st April to 31st March.
11. All the parties hereto shall actively and diligently work in the interest of partnership to their fullest capacity in the discharge of their duties as partner of the firm.


